- a) The funds shall be utilized in accordance with the SDRF guidelines read with Standard Operating Procedure (SoP) issued vide Govt. Order No.Rev/ER/08 of 2015 dated 10.01.2015.
- b) The DDO concerned shall vouch safe the utilization of funds as per the codal procedure/guidelines.
- c) The funds are drawn only for the purpose of calamity arisen as per occurrence of incident.
- d) The Utilization Certificate (UC) of the funds released during current year under SDRF shall be submitted together with the progress report and list of beneficiaries to the department on monthly basis.
- e) The claim shall be settled subject to the conditions that they are sanctioned by the competent authority as per the delegation.
- f) The offices with whom the funds have been placed shall reconcile the expenditure under SDRF with the Accountant General (A&E) J&K, Srinagar/Jammu and send a copy of the same with the Annual Report for the financial year.
