Subject: Constitution of Committee for updating the J&K State Disaster Management Policy.

Government Order No: 70 -DMRRR of 2017 Dated: 01 .09.2017

Whereas, the Hon'ble High Court vide order dated 18.08.2017 in PIL No. 02/2014 c/w PIL No. 08/2017 titled Moulvi Peer Noor ul Haq v/s Chief Engineer & others observed as under:-

"We notice that the J&K State Disaster Management Policy, which has been notified through SRO 218 dated 22.05.2017, was actually prepared in the year 2012. Some of the figures in the policy have been up-dated but the entire policy needs to be up-dated because it doesn't reflect the experience of 2014 floods. Therefore, we direct that the J&K State Disaster Management Policy be up-dated to include all the events & further developments as on date".

Now, therefore, in compliance to orders dated 18.08.2017 passed by the Hon'ble High Court, sanction is hereby accorded to the constitution of the following Committee to update the J&K State Disaster Management Policy:-
